Necessity of The Hope of Survivors

*“The sexual abuse of children, of course, is getting all of the press. But the bottom line is that far more clergy have sexual contact with adult women or late adolescent girls than they do with kids of either gender. And it’s a very widespread problem. People trust clergy like they trust nobody else. So the trust is there. The opportunity is there. Secondly, clergy get carried away with their own power and their own influence.”—Dr. Gary Schoener, Clinical Psychologist [Excerpt from an interview for *Religion & Ethics*, #934]*

Sad, but true, pastoral sexual abuse and misconduct is an ever-increasing problem in our congregations. It is not limited to children or Catholics. It takes place around the world in every denomination. When a pastor or other spiritual leader betrays his sacred trust and takes advantage of his position, power and authority to abuse a member of his (or her) congregation, the result is devastation—for the victim and her family, the pastor and his family, the church body and, oftentimes, the community. The destruction cannot be underestimated. The potential for health problems, suicide risk, breaking up of marriages and families is just the beginning. One of the worst “side effects” of pastoral sexual abuse is the loss of faith, trust and relationship with God. Many victims find it impossible to return to their church—or any church. Yet, that’s not the worst of it. Too often, there are some who never recover from the abuse and remain away from God forever. The responsibility for that victim’s life lies in the hands of the pastor who abused her. The Hope of Survivors works diligently to encourage, edify and strengthen the victim’s faith in God. It is a painstaking and slow process that requires much prayer, patience and love.

The History of The Hope of Survivors

The Hope of Survivors was born one evening in December 2002, as Steve and Samantha were reflecting upon their own experience of pastoral sexual abuse and the lack of resources that were available to help them understand and heal at that time. They felt compelled to develop a web site that would provide information and encouragement to anyone who may be searching for answers. Steve and Samantha felt that if “just one person” could be helped by the web site, then it would be well worth the effort and pain they had gone through. While Steve and Samantha’s vision was limited in thinking “just one,” the Lord knew how many hurting people there were—suffering all alone and living without hope. As you will see in the remainder of this report, there are many “ones” out there who have been touched and blessed by the ministry of The Hope of Survivors. Truly, God does work all things together for good to those who love Him and are called according to His purpose.

The Hope of Survivors has grown rapidly in its services since it began. It has an active Board of Directors, Officers and volunteer staff. It often serves as the only available, unbiased liaison between victims and appropriate civil, public or religious assistance. Its documents, including a series of informational brochures and DVDs, are circulated worldwide. The Hope of Survivors is unique, as a multitude of national web sites exist on the subject, but most either provide angry denunciation of various religious organizations, or they are associated with a particular religious sect and require that affiliation from their clients, or they address the problem from a purely humanistic psychological approach—leaving God and His power to heal entirely out of the equation. Many charge for their services, yet The Hope of Survivors has determined to keep its services free of charge to victims. The need for The Hope of Survivors’ unique services and approach is evident. To God be the glory, what great things He has done!

About The Hope of Survivors

The Hope of Survivors is an interdenominational 501(c)(3) nonprofit organization dedicated to assisting victims of pastoral sexual abuse and misconduct, as well as providing educational and informational materials and seminars to pastors and churches worldwide. Pastoral care is provided through The Hope of Survivors' separate pastoral division, *Calling the Faithful*. Other divisions under development include: Youth, Latino, Australia and Pastor's Wives. Professional memberships include: Adventist-laymen's Services & Industries (ASI) and the American Association of Christian Counselors (AACC).

Description of Mission, Services & Programs

The organization's purpose is to provide hope and healing in Christ through encouragement, support, referral, assistance, educational programs and information to victims of pastoral sexual abuse and misconduct. The organization, and its Officers, Directors, Volunteers and Employees, use the Bible as the standard of their beliefs and philosophies in all areas. The ministry seeks to:

(a) Educate the victims, the clergy, the church body and the general public about pastoral sexual abuse and misconduct, the frequency of occurrences, the moral and social implications involved and the devastating consequences through national media, by disseminating brochures and other related materials, conducting educational and informational seminars, and by maintaining an up-to-date web site;

(b) Conduct retreats and seminars specifically for the victims of pastoral sexual abuse and provide one-on-one counsel and support for the purpose of facilitating their healing and recovery, and helping them to gain a greater understanding of what has happened to them, giving them hope and encouragement, and restoring their faith in their Creator;

(c) Work closely with churches that are dealing with the after-effects of an abuse situation for the purpose of helping them to understand the importance of providing a safe environment for all and for understanding the dynamics of pastoral sexual abuse so that the church and the victim are not further damaged in the after-math;

(d) Provide pastoral training/educational seminars for the purpose of providing prevention information and encouragement, and to work closely with those who have violated their sacred trust and encourage them to make amends to their victims and to receive counseling.

In short, the mission of The Hope of Survivors may be summed up in the motto:

Reaching the Hurting... Ministering to those who have suffered abuse at the hands of clergy.

Calling the Faithful... Providing resources and support to church leadership to help them remain true to their high calling.

Bridging the Gap... Leading the hurting to hope through a healing relationship with Christ.

Organization Funding

Distribution of Brochures

Materials were also distributed at each conference, convention and program. Mailings continued to victims, pastors and to churches of various denominations, as well as a few counseling centers throughout the U.S.

Newsletter

The Hope of Survivors continued to publish and mail out its quarterly newsletter, *HopeSpeak*, to over 700 individuals. A second newsletter to serve the pastoral community, *FaithSpeak*, was developed for the *Calling the Faithful* Division with the first issue being mailed out to approximately 400 church leaders in December 2005, with a January 2006 cover date.

Conferences

During 2005, The Hope of Survivors exhibited at the General Conference Session of Seventh-day Adventists in St. Louis, MO, in June-July; at the ASI International Convention in Sacramento, CA, and the Lake Tahoe Camp Meeting in South Lake Tahoe, CA, in August; held an abuse prevention program and benefit concert in Thompsonville, IL, in August; exhibited at the Thompsonville Christian School Fall Festival in Thompsonville, IL, in November; and conducted a *Trust & Truth* conference for church members and the community at large in Ottawa, Illinois, in October. Steve and Samantha Nelson conducted these conferences and programs. Additional conferences and programs were not scheduled due to the time and expense involved in attending and exhibiting at the General Conference Session that takes place every five years.

How did you first become aware of The Hope of Survivors?

What made you decide to become involved with and/or support The Hope of Survivors?

A couple of reasons—we received so much support from The Hope of Survivors during our time of greatest need, when we were basically abandoned by our church, and we wanted to give back to the ministry that helped us survive the trauma we were going through. Plus, ...we wanted to support a ministry that had been such a blessing to us personally.

Do you plan to remain involved with and/or support The Hope of Survivors? If so, why?

Yes, because even though the initial crisis has passed for us, the after-effects will take years to heal, and The Hope of Survivors has continued to offer wisdom and support throughout the healing process. Sadly, there will always be more victims, as well, and we want to support a ministry that was literally a lifeline to us when we were drowning, so that other victims can find the same support as we did.

First Awareness:

I first became aware of The Hope of Survivors when searching online for some information that would help me with my dilemma. I knew I wasn't crazy, like the people at my former church were making me feel. It was with the utmost pleasure that I stumbled on The Hope of Survivors. As I started to read the website I thought, "Oh my God, I could have written that." I could have written it all.

Involvement:

The Hope of Survivors was instrumental in helping me keep my sanity at the darkest time in my life. I felt so alone and misunderstood until I spoke with Samantha. She helped me to see that God was still with me and never abandoned me. She helped me to realize that what was done to me was wrong and justice needed to be sought. Ironically, my church was driving me away from God while Samantha kept me in His path.

The Hope of Survivors guided me to my Savior. It is with my sincerest gratitude that I continue to support this ministry. Just thinking of others suffering like I have, or worse, is enough to know that this ministry is an unfortunate necessity. This ministry provided me the strength to fight for accountability and justice. I cannot imagine another victim feeling alone. It is for the regrettably inevitable future victims that we must help to continue this ministry. They are not alone. They must know they are not alone.

Continue Support:

Yes, I most definitely plan to continue to support and remain involved with The Hope of Survivors. First, I am still on the road to becoming a survivor and, sadly, still need their support. Second, I have discovered that this ministry is much needed in our society where evil tends to be so prevalent. Church leaders and lay people alike need to be edified regarding abuse and how to properly handle the ramifications of it. While we need to continue to help victims, a large part of rectifying the situation comes with educating the masses. The Hope of Survivors is beginning to do just that. With all the bad that has happened to me, I feel called to this ministry to help make a difference in someone's life just as Samantha has done in mine.

How did you first become aware of The Hope of Survivors?

I found The Hope of Survivors ministry on a link from another website dealing with pastoral misconduct.

What made you decide to become involved with and/or support The Hope of Survivors?

The support and understanding I received when I contacted them told me this ministry was exactly as it was described on their site, "A ministry of compassion, support, hope and encouragement." They were not only instrumental in guiding me through my own spiritual journey, as I struggled with issues that resulted from the abuse of a trusted minister, but were a tremendous help in assisting me as I took on the daunting task of addressing church leaders regarding church policy related to pastoral sexual abuse.

Do you plan to remain involved with and/or support The Hope of Survivors? If so, why?

Absolutely. The Hope of Survivors is a gift from God for those of us who have suffered and whose spiritual lives have been shattered by a trusted minister. None of us can erase the past but, because of this ministry, I now have hope. The need for this kind of ministry is vital to victims of pastoral sexual abuse.
